I (We) authorize Fredericks Fuel & Heating Service to make fuel oil deliveries on an () Automatic Delivery, () Will Call Basis. I (We) understand that with "Automatic Delivery" we shall receive periodic fuel deliveries on an automatic basis provided there is no past due balance at that time, current budget account excluded.

FREDERICKS FUEL is responsible for the delivery of product to the receiving pipe or outlet designated by customer. Customer acknowledges and agrees that neither FREDERICKS FUEL, nor its employees or agents, are or shall be liable under any circumstances for any damages resulting from leaks or for the failure of the receiving tank or associated piping. Customer is responsible for tank and piping.

In consideration of credit extended to me and members of my family, I hereby agree to be responsible for all purchases made on this account. The account will be paid in accordance with the following terms:

1. I will have the option of paying my account in full within thirty (30) days of the billing date without paying a finance charge.
2. A FINANCE CHARGE is computed by a "periodic rate" of 1.5% per month on amounts outstanding more than thirty (30) days which is an annual percentage rate of 18%.
3. A collection fee representing 1/3 of the outstanding balance will be added if the amount is referred to an attorney for collection.
